Subject:- Central Nomination to MD(Ayurveda/Unani/Siddha) Courses- for the Session
2013-14- regarding.

Sir,

I am directed to refer to this Departments letter of even No. dated 04/07/2011, on the above subject (copy enclosed), and to say that the State Governments/UTs were required to sponsor candidates PG Courses in Ayurveda, Unani and Siddha against the Central Pool for the year **2013-14**. However, the State Governments/UTs have not yet nominated candidates till date.

2. The Colleges/Institutes shall prepare a separate merit list for candidates sponsored by the deficient States/ UTs who do not have relevant PG Courses. They shall be admitted against the vacant seats available, if any, after admitting the Government Teachers/ Doctors nominated by the Department of AYUSH, Ministry of Health & Family Welfare, Teaching institutions which have earmarked seats for utilization by this Department, will send prospectus/ Information Bulletin to this Department immediately on its publication and sale to the applicants seeking admission to the M.D. courses. The teaching institutions will fill up the seats earmarked for Central Government nominee only after getting the direction from this Department. The donor institutes/ colleges shall account for these seats provided under Central Pool for purpose of reservation for SC/ST/OBC etc.

3. The Medical Colleges/ Institutions mentioned in the Annexure-I are required to conform to the requirements of the Indian Medicine Central Council Act, 1970, as amended from time to time, and the Regulations of the Central Council of Indian Medicine. Before sponsoring a candidate, the State Governments/ UT Administrations are required to show due diligence in ascertaining whether the college/ institution concerned has received the requisite permission of the Central Government in terms of the provisions of the IMCC Act for taking admission in the relevant academic year. The candidate who applies for being sponsored must be informed

upfront in writing that his/her actual admission in the College/Institution of the course concerned shall depend upon and be subject to the College/Institution concerned having received the requisite permission of the Central Government for taking admission for the relevant academic year.


4. Applications of Government teachers/doctors only may be forwarded to this Department. The letter should be addressed to the Secretary to the Department of Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy and reach this Department **by 21st August, 2013**. For North Eastern States, the last date will be 3rd September, 2013. Applications received after closing date are liable to be rejected. Applications of other candidates from deficient States/UTs may be forwarded to the concerned Institutes directly for entrance test/admission.

5. The Central Government intends to earmark seats in the Colleges/Institutions other than those mentioned in the Annexure I of the aforesaid letter, subject to the permission granted/to be granted to the College/ Institution. Necessary instruction the details in this regard will be issued later.

6. The State Governments/UTs and the Colleges/ Institution are requested to take immediate action in the matter.

7. **The enclosed letter dated 04/07/2011 on the above subject shall remain valid for subsequent academic years unless modified or amended. Also, all relevant date(s)/academic session(s) mentioned in the letter dated 04/07/2011 may please be read as corresponding date(s)/session(s) of the year -2013.**


