**The membership is subject to following terms and conditions:-**

- In terms of sub-section (2) of Section 6 of ITRA Act, it is hereby declared that the office of member of the Institute shall not disqualify its holder for being chosen as, or for being, a member of either House of Parliament.

- ii. In terms of sub-section (1) of Section 7 of ITRA Act, the term of office of a member including nominated or elected member of the Institute shall be five years from the date of his nomination or election.
- iii. In terms of sub-section (2) of Section 7 of ITRA Act, the term of office of a member elected under clause (k) of sub-section (1) of section 6 shall come to an end as soon as he becomes a Minister or Minister of State or Deputy Minister or the Speaker or the Deputy Speaker of the House of the People or the Deputy Chairman of the Council of States or ceases to be a member of the House from which he was elected.
- iv. In terms of sub-section (3) of Section 7 of ITRA Act, the term of office of an ex officio member shall continue so long as he holds the office by virtue of which he is a member.
- v. In terms of sub-section (4) of Section 7 of ITRA Act, the term of office of a member nominated or elected to fill a casual vacancy shall continue for the remainder of the term of the member in whose place he has been nominated or elected.
- vi. In terms of sub-section (5) of Section 7 of ITRA Act, an outgoing member shall, unless the Central Government otherwise directs, continue in office until another person is nominated or elected as a member in his place.
- vii. In terms of sub-section (6) of Section 7 of ITRA Act, a member may resign his office by writing under his hand addressed to the Central Government but he shall continue in office till his resignation is accepted by that Government.
